# 5. Presidents Report

My first CC report for my Presidents year 2023/24,

I was voted in at the Club AGM on Thursday 16<sup>th</sup> February and firstly, thank you to CC members who were able to attend. It was half term week, so many members couldn't make it but I was pleased with the turnout in general. I will include below some of my acceptance speech for reference.

Firstly, welcome everyone to my first Club Committee meeting as President, I'm looking forward to working with you all for the common good of our club. Secondly, welcome to David Balch who joins us as a newly elected CC member, Vicky Rogers as the new ladies golf Captain and Geoff Fidler the new mens golf Captain, looking forward to working with you all and hearing your ideas and input. Sadly, my year has started with 2 Disciplinary procedures to 2 golf members. I was asked by the previous President to conduct these while I was VP and I'm continuing to oversee them now.

The position is: One member was given a written warning for his conduct on 30<sup>th</sup> December but allowed back into club the other was expelled from membership as his conduct was worse on same evening and he has had a previous incident in 2012.

They have both appealed, Deborah has conducted the one misconduct appeal and based on the process being queried the Board have now decided not to renew either

of their memberships in April. Their grievances are ongoing. The Board and management will look to simplify this section of the rules in due course. You will notice a new agenda item inserted this evening. Ideas for "increasing revenue and cutting costs" I want to task the CC with coming up with ideas that we can discuss and put forward to management and Board (like the one extra coffee per week per member idea from Cliff which I think is very powerful!) I have asked the Board and management to accept these in the spirit in which they will be put forward! They may be crazy, unworkable, ridiculous but they will be put forward with the best intentions of a team of people who all have the best interests of the club close to their hearts. It is certainly NOT our intention to tell the management team how to do their jobs! But I'm hopeful of a positive flow of ideas over time, I have agreed with Chris to keep this in for 2 meetings and see how we get on, if we have explored every avenue then we will delete it from future agenda, if anyone has any burning ideas they can bring up under AOB. I attended a Squash and Racket ball committee meeting on Monday 20th, 2 really positive things came out of it: Firstly, Mike has been successful in having starter RB sessions (as reported by GM in his notes) where we converted 12 out of 18 participants to full Squash/RB members where they had not been members before. We are looking to promote this success across the wider membership and social media, they are doing a short video from one member who was really enthusiastic to promote this. The committee are currently arranging this with the management team. Secondly, the club is looking to promote Tin and court sponsorship and you will have seen an e mail to this effect recently. I have been in touch with some section Captains regarding me attending your committee meetings if ok with you all? This will enable me to get a feel for what's going on and If I can help with or attend any events, please let me know. Finally, extracts from my Speech on Thursday for reference. Thank you all for your kind endorsement to Vic's proposal for me to be your next President, it is indeed an honour to be President of this great club. Firstly I would like to thank Vic as your immediate past President for the last 2 years and his tireless work and dedication to the Exeter Golf and Country Club on behalf of all of us, it's not been easy !! I joined in 1981 to play Squash originally when I moved to Exeter from Bristol with my work and the rest, as they say, "is history "Our boys Ollie and David grew up here, learned their sports here and both worked here, Sal and I are both always grateful to the club for helping to shape their formative years. The final few matches of the winter season are due to be played in the next few weeks. The highlight of this season has been the men's A team winning division 1 for the sixth year in a row.


The mixed A team are well placed in their division with a good chance of finishing top, depending on the results of their final two matches next week.
